RELEASE AND WAIVER FOR THE NASH EDUCATION ENSEMBLE/PROGRAM/WORKSHOP

Release of Liability. In consideration of permitting the Releasing Parties to engage in such activities at The Nash, the Releasing Parties agree to hereby fully release, waive, discharge, and covenant not to sue The Nash, its officers, directors, employees, volunteers, agents, representatives and all of their respective spouses, heirs and personal representatives (individually and all collectively, “The Nash Parties”) for, from and against any claims, liens, demands, causes of action, controversies, offsets, obligations, and losses including, without limitation any action, omission, misrepresentation or other basis of liability founded in statute, tort, or contract, and the duties arising thereunder and all claims for personal injuries and/or property damage sustained by the Releasing Parties, which arise out of, occur during, or result from participation in The Nash instruction, programs, ensembles, workshops or other activities or events, whether arising in whole or in part out of the negligence of The Nash Parties or otherwise, that any Releasing Parties ever had, or now have, or which may hereafter accrue, whether known or unknown, absolute or contingent, whether currently existing or hereafter asserted, by reason of any matter of cause, relating to or arising out of any in any way connected with or resulting from participation in such activities or events through The Nash.

Indemnification. The Releasing Parties agree to indemnify and hold harmless The Nash Parties from any and all claims, actions, costs, expenses, and damages including attorneys’ fees that may be incurred as a result of the participation in any activities or events through The Nash.

Video and Photo Release. I understand that representatives of The Nash may be taking photos/videos of the Releasing Parties while I/he/she is participating in an activity through or at The Nash.

The Releasing Parties grant to The Nash and its representatives or successors:

1. Any and all rights that I might now and forever have in the photos and videos, including any copyrights;
2. Permission to reproduce, distribute, and display the photos and videos to the public; and
3. Permission to prepare other works for distribution (such as communication materials or annual reports) based upon the photos and videos for any lawful purpose without compensation.
