PERFORMANCE PROGRAMS INCLUDE CLASSIC JAZZ AND NEW MUSIC PERFORMED BY LOCAL PROFESSIONAL AND TOURING ARTISTS, PERFORMANCES BY STUDENT MUSICIANS; AND WEEKLY JAZZ JAM SESSIONS. THE NASH SERVES THE ENTIRE COMMUNITY BASED ON THE CONVICTION THAT JAZZ IS FOR EVERYONE: CHILDREN, ADULTS, SENIORS AND FAMILIES; MUSICIANS AND NON-MUSICIANS; PRIVILEGED AND UNDER-SERVED YOUTH. THE NASH OPERATES IN COLLABORATION WITH SCHOOLS AND OTHER ARTS AND CULTURE ORGANIZATIONS IN OUR NEIGHBORHOOD, ACROSS THE VALLEY, AND THROUGHOUT AMERICA. AN EXTENSIVE RENOVATION PROJECT WAS COMPLETED IN NOVEMBER 2024.
